## EAA Chapter 42 Board of Directors Meeting Minutes

June 1, 2022

Attending: Lars Gleitsmann (Pres), Rick Henry (Webmaster), Walter Yankauskas, Burke Wick (Dir at Large), Chuck Hosack (Flight Advisor & Tech Consultant), Scott McEwen (VP). Tom Lawhorn (former Pres & Dir at Large) was added to a portion of the meeting via phone call.

Lars called the meeting to order at 7:16 pm.

Scott provided a copy of the minutes from the May 4th meeting. Burke moved to accept the minutes, Chuck seconded; thus, the minutes were approved.

Discussion began with the question, "Do we have a Board of Directors quorum tonight?" Chuck and Walter reviewed "Article IX. Chapter Board of Directors" in our Bylaws (ref <a href="http://www.eaa42.org/bylaws.html#artIX">http://www.eaa42.org/bylaws.html#artIX</a>). By adding Tom Lawhorn via phone, we believed that we met the quorum. Key excerpts from Article IX:

- 2. The Chapter Board of Directors shall consist of the following:
  - Class I Director: Class I Directors shall be the Chapter President, Chapter Vice President, Chapter Secretary, and Chapter Treasurer.
  - 2. Class II Director: Class II Directors shall be three (3) to nine (9) additional members elected to the position of Class II Director.
- 7. A simple majority of the Chapter Board of Directors, at least two (2) of which shall be Executive Officers, shall constitute a quorum of the Chapter Board of Directors.

Most of the meeting focused on Board of Director (BoD) roster (i.e., who are our current, elected directors), quorum requirements, and a discussion of how to adjust the BoD roster to more likely meet the BoD quorum requirements during Alaska Summer months when most of us are hither and yon. Conclusions:

- 1) The Chapter is most likely to have a quorum if we have no more than 3 Class II Directors. Thus, the BoD would consist of the four Class 1 Directors (Pres, VP, Sec, & Treas) and <u>only three elected Class</u> <u>II Directors</u>, for a total of 7 BoD members at any given time. A quorum would then consist of 4 of the seven-person BoD.
- 2) As to the Directors, we determined that the 2-year term would exclude several people who were thought to be Directors, but were not elected/re-elected in the last 2 years. We concluded that Burke Wick and Tom Lawhorn are currently 2 of our 3 Directors. [UPDATE, upon a quick review of 2021 and 2022 minutes, it is not clear that we have 3 membership-elected Class II Directors.]

**June Chapter BBQ**. The June 28<sup>th</sup> Chapter meeting will be a BBQ, hosted at Bernie Willis' home/airstrip. Burke made a motion to allocate up to \$500 for BBQ food and supplies; Lars seconded the motion. Motion passed.

**Young Eagles**. The Board reviewed details of the Chapter's Annual Summer Solstice Young Eagles Rally, Tuesday, June 21<sup>st</sup> at the Pilot's Bldg, Birchwood Airport.

Lars adjourned the meeting by 8:30 pm.
